- Dick presented the 2024 Budget with the actuals and we are on budget
- There was a question last month regarding why the prudent reserve was \$25 off and Dick found out that a check was written to the State for \$25 as a non-profit
- Quickbooks online is still an ongoing adventure, however, it looks like our QB bookkeeper, Michelle, has just about completed the journey
- We have 2 bookkeepers; Bonnie who comes into the office and writes checks, pays bills, makes deposits and enters numbers. We have an outside bookkeeper who transitioned us to online QB, reconciles the checkbook every month and she works remotely
- There will be a discussion next year on how much we want in the checking and prudent reserve accounts
- Lori made a motion to approve the treasurers report Debbie 2<sup>nd</sup>, approved

**Literature:** Lori O

- Lori said that the book inventory is in good shape
- She stated that we have about 30 Plain Language Big Books in stock. The publishers are making a couple of minor changes in language and they are going to re-print the book so more will not be available for several weeks
- Lori said that a volunteer called needing a Spanish translator and Dick said that they are listed in
